## 6. Ex-officio Reports

The following reports were provided verbally:

#### **City of Prince George**

- CPG is planning to change 5<sup>th</sup> Avenue to angle parking. It is currently in the design stage and will likely be implemented in 2017. The current design concept involves painted bulb out with bollards utilized to facilitate pedestrian safety.
- City Council & City Administration will be organizing another 'Talktober' event. There will be 5 evening dates throughout October (12, 18, 20, 24 & 26). DPG has been invited to participate. Staff will attend and Board members are encouraged to join. A sing-up sheet was distributed.
- The business interviews have been completed by Economic Development with a plan to present the information at an October 28<sup>th</sup> Chamber of Commerce event.
- The Select Advisory Economic Development continues to meet. Colleen & Eoin have been participating on behalf of DPG. The group has been engaging in conversations around four mission topics that will ultimately contribute to the final Economic Development Strategy for the City of Prince George. These topics are: Business Retention & Expansion, Business Attraction, Advocate to Retain & Grow, and Market Prince George
- The final strategy should be presented in November and then the work of the committee is complete.

#### **Tourism Prince George**

- The Tourism MDRT 3% application has been approved by the CPG and has now been submitted to the Province for approval. The expected timeline for implementation will be after July 2017.
- The 2017 Visitor Guide is currently in production.
- The Northern BC Tourism Summit will be hosted on Oct 3 & 4, 2016. The keynote speaker is John Montgomery.

#### **Prince George Chamber of Commerce**

- The Chamber of Commerce Business Excellence Awards Luncheon takes place on September 15<sup>th</sup> and will narrow down nominees to 3 in each category.
- The Business Excellence Awards will take place on October 22, 2016.

### **Beautification Committee Update**

- The Emily Carr Neighbourhood Time Exchange | Downtown Prince George, Artist in Residence Program has begun. The studio space is at 1119 3<sup>rd</sup> Avenue. There are currently 2 artists in Prince George.
- DPG is working with the CPG to Graffiti on alterations to the program to better facilitate the mitigation.
- Most of the 2016 façade projects are in progress. Discussions will occur later this year to revise the program for 2017. Suggested to include the Heritage Commission when discussing about how to incorporate a heritage restoration incentive and/or program.

### **Business Development Task Force Update**

- The group is working on collateral for business attraction, out of town guests
- The strategic priorities of the group are focusing on business attraction and retention, downtown districts, downtown living and downtown safety.

## **Events and Promotions Committee Update**

- Downtown Summerfest was a great success staff will be preparing the Celebrate PG grant application to the City by October 15<sup>th</sup>.
- Staff are working with event coordinator, Heidi Martel to plan the activities for the Downtown Winter Carnival on Sunday February 12, 2017
- DPG will be introducing Lovebucks as part of a promotional concept for the Love Downtown PG program. Hoping to expand the concept to other businesses.

• DPG will be attending Student Orientation tradeshow events at CNC and UNBC.
